8. _____ agrees to pay all costs and charges not later than the day of admittance of the pet to PRA-Terrigal and any additional charges incurred by _____ must be paid when _____ leaves PRA-Terrigal.
9. _____ must be dropped off and picked up within the advertised operating hours of PRA-Terrigal or its appointed agents. Any out of hours actions are at the discretion of PRA-Terrigal and may be charged for.
10. Mrs _____ agrees to pay all costs and charges for special services requested and all veterinarian costs for _____ during the time the said pet is in the care of PRA-Terrigal.
